Sir,

The Jammu and Kashmir Services Selection Board (JKSSB) is a prime recruiting agency for the Government of Jammu & Kashmir having the mandate of undertaking recruitments, in a fair and transparent manner, to the non-Gazetted positions, including Class-IV vacancies, as referred to it by various Government Departments. The JKSSB holds examinations, including skill tests wherever required for carrying out recruitment to various posts. Recently, the task of recruiting Sub Inspectors for Jammu and Kashmir Police also has been assigned to the Jammu and Kashmir Services Selection Board.

Backdrop: Time bound completion of a selection process set in motion by the Jammu and Kashmir Services Selection Board is a cherished objective for the Government as well as the Board. It also assumes importance from the point of view of hardworking aspirants, due to enormous challenges posed by soaring unemployment levels. However, it has been observed that multiple factors, both separately and cumulatively, are responsible for delays in the recruitment processes, initiated by the Board. That a host of steps have been taken in the past two years to ensure speedy conclusion of a selection process and significant success also has been achieved in this direction. The Board already has completed major recruitment drives for the posts of Accounts Assistant (Panchayat), PM Package, Class IV, etc. in a time bound manner, despite interruptions caused by the outbreak of COVID-19 pandemic. The subsequent selection processes initiated by the Board in respect of posts advertised subsequently, are also well on track, as far as the time limits are concerned. The Board has regularly been conducting largescale examinations and in the month of March 2022 alone, the Board has conducted three major examinations which include the maiden examination

for 1200 posts of Sub Inspectors in the Jammu and Kashmir Police. More than 2.50 lakh candidates appeared in the said three examinations.

Areas to be Addressed: However, there are two aspects which need to be addressed to further streamline the pace of recruitments, so as to further enhance the pace, besides making the process more convenient and simpler for the candidates. One is the strengthening of the Board by adequately augmenting its existing manpower to meet current challenges on account of increased workload. In this regard, the proposal for reorganization of the Board has already been forwarded to the General Administration Department for accord of approval. Two, there is a need to do away with the practice of holding separate examination for every single type of post advertised by the Board and introduce the concept of Single/Combined examination, wherever feasible.

Adhoc Mechanism: The Board, wherever feasible, conducts combined examination for a particular post, even if requisitions are received from the Indenting Departments at varied points of time. The allocation of posts in such cases is done on the principle of "merit-cum-preference". This saves lot of time, energy and resources of the Board and enables to complete the selection process in a time bound manner. The candidates also are relieved of the pain and stress to appear frequently in multiple examinations with different syllabi and pattern. The candidates also have to incur huge costs for appearing in multiple examinations having different syllabi and pattern. The procedure though adopted by the Board, is at best adhoc and subordinate to the receipt of requisitions/indents from the Departments and there is a need to institutionalize the method, by including not only identical posts within the ambit of single examination, but different posts which can be grouped together, as far as possible, for a combined/single examination.

**Staggered Requisitions:** The Sub-Rule (1) of the Rule 2 of the Jammu and Kashmir Civil Services (reference of vacancies and holding of meetings of Departmental Promotion Committees) Rule 2005 provides that the Departments shall refer vacancies falling under direct recruitment quota to Public Service Commission and Services Selection Board, as the case may be, by or before 15<sup>th</sup> of January every year. However, the experience of past many decades demonstrates that Departments do not follow the prescribed calendar and keep referring the direct recruitment quota posts as per their convenience. Consequently, the JKSSB advertises the posts as and when referred

conducting Examination- Challenging & Sensitive Exercise: Holding of examinations for recruitment is a sensitive, challenging and time bound exercise and to hold multiple examinations round the year increases the challenge manifold. The Board officials in view of the round the year examinations, are always in an event management mode which from safety and integrity point of view, is not a prudent strategy. The Board also squanders substantial time, energy and resources on conducting examinations, leaving little scope for reformation and quality upgradation. The candidates also have to undergo lot of stress and pain for appearing in multiple examinations for various posts, as they have to study multiple syllabi for preparing for each examination. Thus, the candidates are drained both physically and psychologically in the process and they are subjected to undue financial burden also. Holding of multiple examinations for a single post also leads to delays in selection process.

There always remains a pressure on the recruiting bodies as well as the Government to complete the selection processes in shortest possible time. The matter has assumed greater urgency on the one hand, in the backdrop of burgeoning unemployment and on the other hand, due to scarcity of manpower in the Government Departments on account of vacant positions.

Combined Examination: In the aforesaid context, there is an urgent need to examine the possibility of holding combined examinations not only for single type of post but also for group of posts/services as can be clubbed together. The Staff Selection Commission and many other State Recruitment Boards, have developed templates for holding combined examinations. The SSC conducts a combined examination at the Graduate Level and the 10+2 Level, for all such posts which are likely to be referred to it and for which prescribed qualification is similar. Similarly, various State recruitment Boards have devised templates for grouping of various Non-examinations for such services as are grouped together.

Class IV Recruitment- Success Story: No such grouping of services in a systematic manner for conducting single examination has been done in Jammu and Kashmir, except recently with the notification of Jammu and Kashmir Appointment to Class IV

of having a combined examinations are conspicuously visible. The selection process, despite facing many issues due to grey areas in the rules in the wake of changed legal framework post reorganization of Jammu and Kashmir State, could be completed in a speedy and transparent manner. Previously, the Class IV posts were recruited by respective Deputy Commissioners/HODs and it used to take time to conclude such selections with no uniformity in the scheme of selection. As such, there is a need to build on the success story of Class IV recruitment and take the reformation process to the next higher level, and explore possibility of having combined examinations, by grouping such services together which are of general nature and for which no specialised knowledge is required.

It has been observed that the following posts are being referred by the departments from time to time for recruitment and these posts can be grouped together to hold a combined examination for making selections for them.

The above list is illustrative and respective Departments can also suggest such additional posts as can be grouped together for notifying a Combined / Single Examination.

## Advantages:

- 1. Combined examinations will save candidates from the botheration of appearing in multiple examinations, and multiple examinations mean more burden on unemployed youth in terms of wastage of resources and energy.
- 2. Combined examinations will save candidates from repeated pain and hardships of appearing in multiple exams for identical or similar posts.
- 3. The selection process will be completed in a far more speedy and transparent manner on the basis of the common merit.
- 4. There will saving of lot of time, energy and resources of the Board which can be utilized for quality upgradation and reformation as well as improved service delivery. Otherwise, the Board officials in the present ecosystem are always in an event management mode and firefighting mode
  - 5. Help in producing the finest quality of manpower in a hassle free and time bound manner through a transparent and fair conduct of a single examination.

In view of the above, it would be in the fitness of things to hold a single/combined graduate level examination for all such similar posts belonging to different Departments for which the prescribed qualification as well as job profile is same / similar. The final allotment of posts/departments can be made based on the principle of merit-cum-preferences of Posts/departments indicated by the candidates. Accordingly, it is recommended that the Jammu and Kashmir Services Selection Board be allowed to introduce a combined Graduate level Examination for all aforementioned similar posts which are likely to be filled up in a calendar year as per the pattern of examination recommended hereunder:

pattern of Examination: The Examination shall comprise of a 2-tier system consisting of Tier 1 CBT/OMR based Objective type, Multiple choice examination and Tier -2 pen and paper (OMR) based Descriptive Paper / Computer Proficiency Skill Test, wherever required.

**Fixed Calendar**: In order for the above scheme to be successful, the foremost prerequisite is that a fixed and definite calendar for the said Combined Graduate Level
examination is notified and the said examination calendar is to be kept independent
of the requisitions to be received from the respective Indenting Departments. The
Board in anticipation of vacancies to be referred by designated Indenting
Departments, shall conduct examination as per a fixed calendar and draw a merit list.
The candidates to the departments shall be returned within a calendar year to the
requisitioning authority at any point of time upon receiving of indents/requisitions.
However, it would be of prime importance that the Departments follow a definite timeframe for furnishing requisitions/ indents to the Board.

BROTH THE STREET HAS BUT LIST Shall remain valid for a period of one year from the date of its publication and can be extended for another six months on the specific request of the Indenting Department.

In view of the above, it is therefore, requested to consider the proposal for holding a Combined Graduate Level Examination for accord of approval.
